## Rules & Regulations:

- **Eligibility:** ONLY TRIPURA STATE PLAYERS ARE ELIGIBLE TO PARTICIPATE IN THE CHAMPIONSHIP.
- **Age Limit:** PLAYERS SHOULD BE BORN ON OR AFTER 01.01.2006
- **Prizes:** TROPHIES WILL BE GIVEN TO TOP FOUR BOYS AND TOP FOUR GIRLS DURING ANNUAL PRIZE GIVING CEREMONY.
- **Selection:** TOP FOUR BOYS AND TOP FOUR GIRLS WILL BE SELECTED FOR BOTH OPEN AND GIRLS NATIONAL CHAMPIONSHIP FROM THE FINAL RANKING OF ONE OPEN COMMON TOURNAMENT.
- **Financial Assistance:** FOUR SELECTED PLAYERS EACH FROM BOTH CATEGORIES WILL GET RS 3000/- (THREE THOUSAND ONLY) EACH AS TRAVELLING ALLOWANCE AFTER NATIONAL PARTICIPATION.
- **SCHEDULE :** 25<sup>TH</sup> OCT'25 : 9:30 AM / 13:00 PM / 17:00 PM  
26<sup>TH</sup> OCT'25: 9:30 AM / 13:00 PM / 17:00 PM  
27<sup>TH</sup> OCT'25: 9:30 AM / 13:00 PM / 17:00 PM
- **System of Play:** THIS WILL BE AN OPEN RATING TOURNAMENT AND WILL BE PLAYED UNDER FIDE LAWS OF CHESS. TOTAL 9 ROUNDS WILL BE PLAYED IN SWISS SYSTEM.
- **Default Time:** DEFAULT TIMING FOR ARRIVING TO THE CHESS BOARD IS 15 MINUTES.
- **Time Control:** THE RATE OF PLAY SHALL BE 60 MINUTES WITH AN INCREMENT OF 30 SECONDS FROM MOVE NUMBER ONE.
- **In case of tie,** THE LATEST FIDE APPROVED TIE BREAKS WILL BE FOLLOWED.
- **Draw Agreement:** PLAYERS SHALL NOT AGREE FOR A DRAW WITHOUT CONSENT OF THE ARBITER, BEFORE EACH PLAYER MAKES 30 MOVES.
- **Protests,** IF ANY, AGAINST THE DECISION OF THE CHIEF ARBITER, SHALL BE MADE IN WRITING WITH A PROTEST FEE OF RS.1,000/- (RUPEES ONE THOUSAND ONLY) WITHIN 30 MINUTES OF THE OCCURRENCE OF THE INCIDENT. THE AMOUNT SHALL BE REFUNDED IF THE APPEAL IS UPHOLD
- **Electronic Devices:** ALL ELECTRONIC ITEMS INCLUDING WRIST WATCHES (ALL TYPES OF WATCHES) ARE NOT ALLOWED IN THE HALL

- **Appeal Committee:** BEFORE THE START OF THE TOURNAMENT, AN APPEAL COMMITTEE WILL BE FORMED BY ATCA.

- **AICF Registration:** AICF REGISTRATION FOR THE FY 2025-26 IS A MUST FOR EVERY PLAYER. WITHOUT **ACTIVE AICF ID**, NO PLAYER CAN PARTICIPATE IN THE TOURNAMENT.
- **Last Date of Entry:** NO ENTRY WILL BE ACCEPTED AFTER 5 PM OF 24<sup>TH</sup> OCT'25.
