## IMPORTANT POINTS TO REMEMBER:



**Venue:** NSRCC, Chess Hall, Agartala



**Eligibility:** Only Tripura State Players born on or after 01.01.2008 are eligible to participate. All entries should be strictly routed through All Tripura Chess Association.



**Prizes:** Trophies will be given to top 4 (four) players in each category.



**Selection:** Top 2 (two) players in each category will be selected for the National Event to participate at normal entry fee.



**Monetary Benefit:** Top 2 (two) players in each category will get Rs.3, 000/- (Rupees three thousand only) each as travelling allowance after participation in the National Event.



**Round Schedule:**

31 <sup>th</sup> October:	09:00 AM/ 01:00 PM/ 04:00 PM

**System of Play:** The Championship will be played under FIDE Laws of Chess and the Swiss System. A total of 06 rounds shall be played.



**Deafault Time:** Default timing for arriving to the Chess Board is 30 minutes.

**Time Control:**

The rate of play shall be 60 minutes with an increment of 30 seconds from move number one.



**Tie-Break:**

The following is the order of Tie-Break.



1. Buchholz Cut 1
2. Buchholz
3. Sonneborn Berger
4. Direct Encounter
5. The greater number of wins including forfeit.
6. Number of wins with black pieces.



In case of tie, prizes will not be shared.



**Draw Agreement:**

Players shall not agree for a draw without the consent of the arbiter, before each player makes 30 moves.



**Protests:**

Protests, if any, against the decision of the Chief Arbiter, shall be made in writing with a protest fee of Rs.1,000/- (Rupees one thousand only) within 30 minutes of the occurrence of the incident. The amount shall be refunded if the appeal is upheld.



**Appeal Committee:**

Before the commencement of the tournament, a five member Appeal Committee shall be formed by the ATCA.



**Electronic Device:**

All Electronic Devices including wrist watches (all types of watches) are not allowed in the Tournament Hall.



**Fair Play:**

FIDE Fair Play Regulations will be applicable during the event.
